My daughter the terrorist

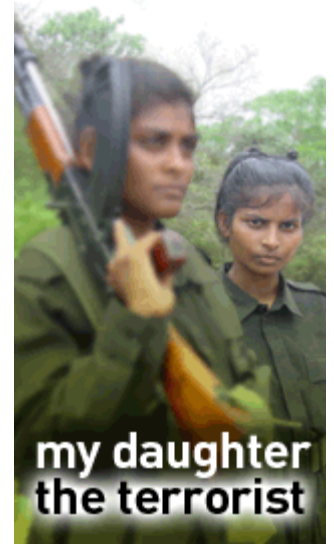
The Norwegian funded propaganda movie about the LTTE Black Tigers is used by the LTTE to raise funds and to justify the horrific terror is committing in Sri Lanka. The movie is carefully scripted to target the Christian audience in Europe, Australia and America.

The producer Ms. Beate Arnestad is attempting to hide the fact that the documentary received funding from the Norwegian Government. This is only partly true. The first funding for the documentary came from the Norwegian Government film fund who gave the producer 250.000 Norwegian kroner (50.000 US dollars). The funds was given to the producer in 2005!

The documentary producers are admitting they falsified their visa applications in order to make the LTTE propaganda film.

Assisted by the Norwegian Government the producers provided a cover story to the Sri Lankan authorities that they wanted Visa's to Sri Lanka in order to make a documentary about the Tsunami.

The producers had already made agreements with the LTTE for filming in the LTTE occupied areas.

Norway is violating all diplomatic rules and assists in smuggling in a film team to help

the worst terrorist organization known to mankind to make a propaganda documentary.

To add insult to injury the Norwegian Government has granted the producer more funding in 2008!

Norway has channeled the funds to the producer as a "S-Film" aid, so the documentary can be distributed on DVD and video.

If this is not enough we have found the Norwegian MFA granted the documentary funds through the NORAD agency. It seems to us this documentary was not only important for the LTTE, but also for the Norwegian MFA. The MFA

want to show the Norwegian people they have funded a Christian separatist group and not a terrorist organization.

The Norwegian tax payer's money spent on first class tickets, luxury hotels, alcohol, brothel visits in Bangkok is justified, seems to be the message from the Norwegian Ministry of Foreign Affairs want to convey to the Norwegian people with the LTTE documentary.

The LTTE is already using the documentary for fundraising and propaganda purposes. Once again we see Norway pay the cost for the LTTE fundraising for terrorism.

“During an internal routine inspection of the suspended Norwegian People's Aid (NPA) Mine Action Programme equipment and resources on Thursday 24th July, 2008, it was discovered that 8 vehicles had been forcibly removed from the Mine Action compound in Kilinochchi during the preceding days.”

The above are the official (NPA) explanation of the missing vehicles released in a press release dated 29th July

2008.

In an interview with NRK (Norway's largest TV channel) Mr. Petter Eide is fuming over the Sri Lankan media and GOSL theory that the vehicles has been given to the LTTE.

It puzzles us the NPA has so bad security and it takes them days to find out a substantial number of vehicles is missing. Since their work in Sri Lanka is funded with Norwegian tax payer's money they should take

more care of NPA assets.

NAT cannot prove if the vehicles is stolen or handed over to the LTTE, but it will not surprise us if the vehicles are recovered with the original keys. The NPA Sri Lankan projects are funded by Erik Solheim's NORAD and we assume replacement vehicles will be given to the NPA from the generous LTTE friend Erik Solheim.

UNP –MP Maheswaran killing – Norway link



Member of the Sri Lankan Parliament Mr Maheswaran of the United National Party was killed by LTTE assassin number 1527. The assassin was under the command the of Master Madhivan.

The assassin opened a bank account in a commercial bank in Kotahena. To this bank account funds was remitted to him from Norway, so he could continue to be a sleeper terrorist cell for the LTTE, awaiting order for his next victim.

In December 2007 the LTTE gave him the order to kill MP Maheswaran. They provided him with a Micro pistol and 39 rounds of ammunition. He loaded 14 rounds of ammunition in two magazines and hid 25 rounds in his Wattala home.

It surprises us why nobody seems to be interested to investigate the Norwegian link to MP Maheswaran murder. After eight months no request has been made to identify the source of the assassins Norwegian funding.

LTTE is using Norway to transfer funds to the LTTE terrorist cells.

An investigation into who funds the LTTE assassins could reveal more LTTE terrorist sleeper cells and stop future murders. It could be most interesting to see if more political murders have been funded from Norway.

Erik Solheim and the Norwegian police do not seem to care if LTTE is using Norway to disburse funds to kill Sri Lankan politicians and civilians.

In an interview the Norwegian Ambassador to Sri Lanka, Mr. Tore Hattrem gave to Mediill News Services April 7th 2003, He said **"We see ourselves as facilitators, not mediators,"** Hattrem said. **"We won't come in with a large amount of carrots and sticks. We go into this process with a very small carrot, such as money to oil the machinery and get things done faster, and the stick is there. We can't threaten the parties with anything."**

In his interview he confirms Norway is using its oil funds to lubricate the peace

"facilitations" they are involved in. With 40 million US dollars (official) in "carrots" every year allocated to Sri Lanka the lubrication is substantial.

NAT have alleged and proven Norwegian funds have been used to fund the LTTE and its front organizations. We have seen from official statements from the Norwegian Ministry of Foreign Affairs that Sri Lankan journalists, peace "experts" and politicians have been funded.

Colonel Karuna and others have alleged Norwegian funds have been used to manipulate Sri Lankan

elections.

Sri Lankan's should demand a full disclosure of all the facts from the Norwegian MFA.

The use of Norwegian money to "lubricate" is an insult to the Sri Lankan democracy.

The facts show the Norwegian bribes have not worked. It has only made the situation worse. The use of lubrication has destroyed Norway's credibility, not only in Sri Lanka, but in all other peace process Norway's is involved in.

We have all heard about the LTTE’s Charles Antony Brigade, Sothiya brigade and The “Baby brigade”. Lesser known is what NAT like to call the LTTE “Cry-Baby” Brigade (CBB). CBB is an international brigade that operates in countries where there is a large Tamil Diaspora.

The CBB has no soldiers, but journalists, activists and politicians.

The CBB control a huge media apparatus used to distribute LTTE propaganda. Tamilnet is the best known CBB website, but they have more than fifty websites under their command.

The CBB activists and local LTTE politicians are used to infiltrate and manipulate foreign organizations and political parties. Some CBB activists work as volunteers for local politicians and organizations.

The CBB works on two fronts. First front is to manipulate the Tamil Diaspora with false information. One of CBB goals is to gain support and funding from the Tamil Diaspora.

CBB Second front is to manipulate politicians, NGO, human rights organizations, media, churches and other that could be useful for the LTTE.

In Britain LTTE chief Cry-Baby Ivan Pedropillai has been requesting Cardinal O’Connor and other church leaders to pray for the Tamils! Mr. Pedropillai has arranged demonstrations against the Slovakian Embassy protesting arms sale to Sri

Lanka.

The CBB is fabricating the most outrageous stories and have been able to convince their target groups.

The CBB want to drum up support for the LTTE by smearing the Sri Lankan Government and the Sri Lankan Army. The CBB accuse the Government of Sri Lanka (GOSL) for state terrorism!

CBB says GOSL block humanitarian aid. They are accusing the Sri Lankan army of abduction of Tamils. One example is Mr. Velayudan Sudarshan. He was allegedly abducted by the SLA. The truth is that he was in the custody of the LTTE and training for a suicide mission.

The CBB try to convince their targets the LTTE is the sole representatives of the Tamils. LTTE does not represent the Tamils, a tiny percentage of Tamils support the LTTE, due to false information.

The CBB is actively lobbying politicians and promise them votes if they support the LTTE.

The CBB has been able to get foreign governments and human rights organizations to put pressure on GOSL. The CBB, with the help of Norway, was able to delay the terrorist listing of the LTTE in Europe and Canada.

In Norway the CBB have been able to convince all the political left politicians and several NGO’s with their stories.

NAT is amazed how successful the CBB have been in duping their target groups. We are puzzled of how easy it is to manipulate foreign politicians to work according to the LTTE strategies.

Liberal politicians in England and Canada have been easy targets for the CBB propaganda.

Even the US State Department has been a victim of the CBB propaganda machinery. The US State Department Country report on Human Rights is full of errors.

The CBB has now lost most of their credibility and foreign politicians have become increasingly critical to their propaganda.

In Australia, Canada, Denmark, England, France and Italy the LTTE has had large setbacks.

Fundraisers has been arrested, funds and material confiscated.

All of the above nations are very important for the LTTE. It is in these nations they get most of their funds.

There can be no doubt the continued pressure from the Sri Lankan Diaspora organizations have been vital for both the terrorist listing of the LTTE and the enforcement of the ban.

SPUR, SLUNA and pressure groups in Denmark, England, France and Italy has been in the forefront to get the local law enforcement to take action.

The Sri Lankan Diasporas

activism has been a major wake up call for politicians and law enforcement.

There has been a significant increase in activity from the Sri Lankan Foreign Service. This has given good results:

- ✚ In Denmark all TRO accounts has been arrested.
- ✚ In Canada the WTM has been raided.
- ✚ In Italy the police have arrested 33 LTTE fundraisers.
- ✚ In France the LTTE criminal network has been exposed. Large demonstrations against the LTTE terror were held in

Paris 28th July.

- ✚ In New Zealand they decided to freeze funding to the TRO.
- ✚ In England we have seen arrests and large demonstrations against the LTTE terror.

There can be no doubt the Sri Lankan Diaspora and Sri Lankan Foreign Service fight against the LTTE has saved a lot of lives in Sri Lanka and speeded up the down fall of the LTTE terrorism.

LTTE is totally dependent of foreign funding and arms supply, by cutting of the LTTE supply lines the LTTE is doomed.

Sri Lanka and the global war against terrorism

The Sri Lankan contribution to the global war on terror seems to have been forgotten in the media.

We have to remember the LTTE is not only a threat to Sri Lanka and India, but to all nations.

In next column there are some **facts** from the SLMM statistics for the period 01/03/2002 to 30/11/2005.

From the statistics we can see the LTTE fabricated more than 1000 lies about the SLA.

LTTE filed a total of 1263 complaints to the SLMM of alleged SLA violations. Only 153 were ruled to be true! Where of only 3 violations can be classified as serious human rights violations!

SLMM found LTTE have violated the CFA 3423 times!

Unfortunately many international organizations and politicians lobbied by the LTTE “Cry-Baby” brigade are buying into the LTTE lies, fabrications and distortion and facts. At the same time they forget the LTTE is both a terrorist organization and one of the worst human rights violators known to mankind.

As far as NAT can see there are no **independently verified** Human Rights violations by the SLA after the CFA was cancelled.

It is too soon to say there have been no violations by the Sri Lankan Army, but if any, it would be isolated incidents. Unfortunately some soldiers lose their temper in the heat of the battle and commit crimes. We are sure the violators will be duly prosecuted as soon as the war is over.

Even in the US and British army we have seen soldiers commit Human Rights Violations. We are pleased to see many of them now are prosecuted and sentenced.

What is important to know is that Human Rights violations are a **RULE** for the LTTE. The LTTE cadres are indoctrinated from the LTTE leadership to violate Human Rights and commit acts of terrorism.

For the SLA Human Rights violations are unorganized and isolated incidences that will be prosecuted.

It is sad those who voice their concern about their about SLA Human Rights violations do not take the time to check the facts and investigate the credibility of the accuser, the LTTE.



Philippines – Abu Sayyaf reduced to bandits

The Philippines has efficiently been able to crush the Abu Sayyaf terrorist organization. Philippine armed forces Chief General Alexander Yano said Abu Sayyaf is reduced to plain bandits.

The number of terrorist is reduced to around two hundred. Abu Sayya has significant leadership and organization problems.

Financially Abu Sayyaf has reduced capability to launch terrorist actions. Jemah Islamiya (JI) has cooperated closely with Abu Sayyaf. JI has

provided bomb making training and funding for Abu Sayyaf.

Another Philippine terrorist group that has lost support is Moro Islamic Liberation Front (MILF). MILF has according to the Philippine Army 9.600 cadres. MILF has never been weaker than they are today. Despite the reduction of the MILF strength, MILF still is a significant terror threat.

MILF has previously cooperated with Al-Qaida and MILF cadres has been trained in Al-Qaida training camps.

After the 9/11 terror attack MILF has distanced themselves from Al-Qaida.

The Philippines war on terror has been a success. All terrorist groups in the Philippines have lost strength. Simultaneously the Philippine Government has been able to address many of the complaints from the minority groups and thereby reduced recruitment to the terrorist groups.

The terror risk was significantly reduced before new “peace” initiative in Philippines recently revived the

Philippines – Norway make problems again?

Norway is becoming desperate to find work for the large Norwegian Peace industry.

After Mr. Brattskar meeting in Manila the parties agreed to meet in Oslo. The meeting took place 13-15 May and little was achieved.

In Malaysia talks with the MILF terrorist did take place.

The Philippine terrorist organizations soon found they had to increase their leverage in the negotiations. The only way they could do that was to commit more acts of terror.

The “peace” initiative reignited the terror. Numerous acts of terrorism have been committed. A bus bomb exploded the 24th July,

where 27 civilians were injured.

The various terrorist groups in Mindano, Philippines have occupied villages and more than 130.000 have become refugees.

In our opinion the Philippine government does not need any outside assistance in resolving the conflict with minority groups and to stop domestic terrorism.

The Philippines is now looking into resolving the minority group conflict by implementing a federal governing system.

To resolve the problems with the terrorist and extortion groups is a different issue. It remains to be seen if this can be done without the assistance of the Philippine Army.
